GUIDELINES FOR SAFETY DIRECTOR

The Safety Director reports directly to the Contest Director and is responsible for the following duties:

Pre-Contest Tasks

- 1. Determine procedures for obtaining weather and NOTAMs and how to disseminate to contest participants.
- 2. Determine procedures for aircraft parking for competitors and transients
- 3. Determine procedures for Taxi Flows, Fueling, Takeoffs and Landings, Runway Changes, Hot/Cold Box Operations, Traffic Patterns, Holding and Radio Communications.
- 4. Coordinate with local Air Traffic Control regarding air traffic procedures during the contest and Flight Service Stations concerning NOTAMs for Box activation.

Contest Tasks

Pre-Flight Competition Briefings

Conducts pre-flight competition briefings in conjunction with Contest Director and Chief Judge. As a minimum topics will include:

- 1. Weather/NOTAMs
- 2. Taxi Flows
- 3. Fueling
- 4. Takeoffs and Landings
- 5. Runway Changes
- 6. Hot/Cold Box Operations
- 7. Traffic Patterns
- 8. Holding Plan
- 9. Radio Communications
- 10. Divert Fields

Ground Safety

- 1. Monitors crowd and aircraft movements during entire contest period on and off the flightline.
- Directs remedial actions for any noted unsafe activity, assisted by Security for crowd control and Starter for aircraft movements.
- 3. Directs emergency crash recovery equipment and personnel.

4. Assists Medical Director concerning emergency medical equipment support.

Flight Operations

- Weather: Monitors and Briefs weather Observation and Forecast, recommends Go/No Go decisions to Contest Director in conjunction with Chief Judge
- Coordinates with ATC elements concerning Flight/Box Operations and FSS for Box activations NOTAMS.
- Monitors competition aircraft for fitness to fly-- recommends Go/No Go decisions to Contest Director in conjunction with Technical Committee.
- 4. Monitors competitors during flight and ground operations for unsafe performance and fitness to fly. Recommends Go/No Go decisions to Contest Director in conjunction with Chief Judge.

Post Contest Tasks

- 1. Solicit contest lessons learned from participants as to the over all safe conduct of the contest.
- 2. Forward a brief report with lessons learned to the IAC Safety Committee Chairman.

In case of mishap or incident, contact the IAC Safety Committee Chairman immediately.
