

#### 1. General

The U.S. National Aerobatic Championship is organized by the International Aerobatic Club, Inc. (IAC), P. O. Box 3086, Oshkosh, WI 54903-3086.

#### 1.1. Venue

The 2020 U.S. National Aerobatic Championship will be held at the Salina Regional Airport (KSLN), Salina, Kansas USA. The Nationals will be situated on the grounds of a former WW II and Strategic Air Command base just west of Salina, Ks and Interstate I-135.



Salina, Kansas is 90 miles north of Wichita (KICT), Kansas, the General Aviation Capital of the World. Kansas City is 181 miles east of Salina. KSLN, KICT, and KMCI are all served by scheduled airline services.

#### **2.5.** Line Judges

Judges will be selected in accordance with the process in IAC P&P 501 and is based on available judging analysis, regency of experience, and overall performance.

Judges eligible to judge at Nationals include all IAC National Judges as well as Regional Judges who have logged 250+ contest flights judged. Names of the balance of judges for each category will be provided in Annex 3 in a future Bulletin.



# 3. Schedule

The overall flight sequence is highlighted below. A detailed schedule follows. The initial plan is based on seventy pilots with six flights an hour. Estimated sizes of the flight categories for the initial *planning only* are 25 for Primary/Sportsman, 15 for Intermediate, 15 for Advanced, & 10 for Unlimited. This includes powered and gliders. The schedule will be frequently updated as registration develops.

If we overachieve on our flight rates and it looks like Thursday will have extra time, conceptually we are considering having the members in attendance from the 2020 US Advanced Team fly a fourth flight under the CIVA timed format with an unknown distributed on Wednesday. We will NOT do the figure selection and sequence construction process for this concept but instead give the team pilots the same unknown.

#### 5. Competitors, Aircraft and Fuel

#### 5.1. Competitors

- 5.1.1. All Competitors must:
  - a) Be current members of the IAC; or hold a valid FAI Sporting License issued outside the USA.
  - b) Must possess a minimum of a Sport Pilot certificate if flying a qualifying Light-Sport aircraft (LSA), or at least a Recreational Pilot certificate with rating appropriate for the class of aircraft to be flown (power or glider) if flying an aircraft other than a LSA. However, a pilot with a Sport Pilot certificate may fly a non-LSA aircraft in Primary or Sportsman, if accompanied by a Safety Pilot (See 2.2 of the IAC Rulebook) who holds the appropriate certificates and endorsements for the aircraft in question.
  - c) All competitors, regardless of pilot certificate held, must either be in compliance with the FAA rules for medical certification that are in effect at the time of the competition, or hold a current medical certificate appropriate to the pilot's license from another country or the appropriate form issued by any branch of the U.S. Armed Forces. The appropriate proof of medical certification must be shown to contest officials on request.

All such documents shall be presented upon registration for the contest.

5.1.2. Unlimited competitors in the Power category should come prepared to submit Free Unknown figures in accordance with the rules provided in IAC P&P 503.

# 5.2. Aircraft

- 5.2.1. Each participating aircraft must have a valid Certificate of Airworthiness or Permit to fly, valid for aerobatic flight, in accordance with FAA regulations.
- 5.2.2. Each aircraft must have a Certificate of Insurance against Third Party Legal Liability (equivalent to one million USD); this certificate must cover the aircraft for use in aerobatic competition.

#### 5.3. Fuel

- 5.3.1. Fuel is not included with the entry fee. The IAC has negotiated a \$0.50/gallon discount with AvFlight during the contest and on departure day. See their web site at <a href="https://www.avflight.com/Network/KSLN">https://www.avflight.com/Network/KSLN</a>
- 5.3.2. Competitors wishing to purchase fuel with AvFlight must fill out a Registration Form. These are available upon arrival or may be downloaded.



#### 6. Entry Fees – Power and Glider

- Entry fees include video-taped competition flights, BBQ dinner on Saturday night, Taco Tuesday, and closing event on Thursday night.
- Hangar fee for the week is \$100/aircraft which is not include in entry fee.
- Entry fee Deadline September 11, 2020. Late fee after September 11<sup>th</sup> is \$50 for all categories.
- We will fully refund entry fees if you decide not to attend or the contest is not held. For now, please register on the IAC portal.
- Once your fee is received, you can contact the CD and request your scheduled practice slot on Friday or Saturday. Salina is in the Midwest time zone, UTC+5.
- We have 132 practice slots available and will give you your first choice on the first paid/first serve basis. After everyone who is registered gets one flight, we will offer a second practice slot to fill up the daylight. Second practice slots will be offered again based on first paid/first served basis and scheduled by the CD to rationally maximize the spacing between flight one and flight two.

# 7. Accommodation and Transportation

We are on a FAA controlled airport with commercial traffic so ramp access is tightly controlled. No vehicles are allowed through the gates to the activity side of the airport (ramp, apron, anywhere) without a gate card. We will have vehicles to help shuttle people on arrival to the fence line to help unload their airplanes if required.




# 11. BOX PROCEDURES


# 11.1 Field Overview – North and South Runway Operations

We have shifted the 2020 box 200 yards east of the 2019 location. This will help the west judge's location have improved radio communications, departure visibility and easier ground logistics especially y if it rains. Flow templates for powered aircraft when the active runway is 17 or 35 are provide below. The flow templates anticipate that the official contest direction may not be the same as the active runways. Circumstance when the wind direction is east/west are also considered.
























For the tow plane & glider pilots, we are working to develop an east hold for this year's contest. Conceptually we will get in contact with the tower before departure for clearance to cross runway 17-35 into the glider hold areas.







# 11.2 Ramp

General Overview and zoomed in view of ramp.









We will have small, numbered traffic cones on the ramp to help make this system visual. It will also assist in public health concerns related to COVID 19. Push you plane to you starting position please when you feel comfortable, but the earlier the better.

# **11.3 Ramp Operations & Departure**

Hangar 606 has doors on both the North and South end of the facility. We will group categories on each end of the hangars to allow starter to focus on one side or the other. The below distribution splits the aircraft ~50-50. See hangar diagram following page.


- North Ramp Primary, Sportsman, Unlimited
- South Ramp Intermediated & Advanced
- Once cleared to start/started, powered competitors contact Salina ground and advise you have ATIS information A- Z.
- Expect intersection departure on runway 17 35 from Taxiway D. Runway 17-35 is 12,301 ft. in length.
- Upon departure from runway 17-35 fly runway heading until you are cleared to turn west towards the appropriate hold area.
- You will be instructed to change to box frequency. Monitor box frequency, but do not check in, pilots are on this frequency flying in the box. You will be contacted as required.



**Glider operations** will be briefed in detail at the event. We plan to use runway 18-36 for a majority of glider and tow plane operations. We are working on a hold area for the gliders above the Class D airspace on the east side of the box this year. Launch and recovery will be off of 18-36 and then tower will approve transition east over the 17-35 centerlines to climb and hold.

# 11.4 Recovery, Landing, Taxi to the Ramp, and Parking

Upon sequence completion, exit the box, climb or descend to 1000' AGL on downwind for runway 17 or 35 and contact Salina Tower. Tower will advise base turn and landing instructions. Be cognizant of landing and departing aircraft and aircraft in transit to and from the holds. Plan on exiting runway 17 at taxiway *Foxtrot* or exit runway 35 at taxiway *Bravo* or *Charlie* or as assigned. Park on the requisite side of the hangar. Obey Dead Prop Zones.





#### 12. Internet Communications & Social Media

In the weeks prior to the Nationals, news items are published on various media sites including <u>www.iac.org</u>, Facebook, *Sport Aerobatics*, and IAC's *In the Loop* e-newsletter. While the Nationals is in progress, the Communications Director will post updates using WhatsApp . This will be the primary method of communication with participants as well as updates in Hangar 606.



**Note:** Hangar 606 will serve as Contest Headquarters. Pilots should taxi into hangar ramp area upon arrival via Alpha.



#### 14. Arriving at Salina Regional Airport

- 14.1 Arriving by plane. Primary, Sportsman and Unlimited pilots taxi to the North side of Hangar 606 and shut down. Advanced and Intermediate pilots taxi to the South side of Hangar 606 and shut down. No spinning props or coasting within 50 feet of the hangar door entrances!
- 14.2 If arriving via car, exit interstate I-135 on West Shilling Road, exit 89. Go west for 1.25 miles. Turn right on Arnold Avenue. Drive North on Arnold Avenue for 0.4 miles. Arnold Avenue will turn to the right at that point. Turn left at the middle of that right turn and continue north for 0.2 miles to the parking lot on the east side of Hangar 606. Park car and find a contest official.
- 14.3 Rental cars from Long/McArthur Ford will be pre-positioned in the parking lot on the East side of hangar 606. Private and rental vehicles will not be permitted on the flight line! Baggage may be transferred from your airplane via the loading dock at the SE side of Hangar 606. See a contest official if you need assistance.

#### 15. Scoring at Nationals

Scores at the U.S.A. National Aerobatic Championships will be calculated using JaSPer scoring software, the same system used at all regional IAC contests. The contest organizers will make sure that the judges scoring performance and parameters linked to ACRO (previous scoring software) will get feed into the system to give proper international/CIVA credit. JaSPer does not include fair play nor Perception Zeros (see below.)

On the judging line, the judges will be using the nomenclature accepted by JaSPer, and hence there will be the familiar Numeric (0.0) and Hard Zeros (HZ). You may see a (PZ) or Perception Zero on your native Form A in addition to a HZ. This is for judge's subjective perception, rather than a demonstrable fact; they are used to denote the lack of autorotation in a spin or snap; snap rolls in a rolling turn; and no sliding in a tail slide. The PZ is used CIVA and ACRO judging ranking system. This should only apply to the Unlimited pilots as this is where the CIVA ranked judges are assigned.

To further assist our judges who seek CIVA ranking, each Unlimited pilot's Free Program will require an additional number called the Super Family (SF) number. This SF number must be input for each figure such that the statistical analysis is comparing "apples with apples" across all pilots and how they are judged. The SF number is automatically generated by the sequence generating software used, OpenAero or Aresti-Visio. All the pilot must do is to tell the software of their choice to print the SF number on the Form A. Unlimited Free Programs without the SF numbers will not be accepted at registration.

# Annex 1 – COVID 19 Operational Considerations

Please be advised that we will continue to update this annex to provide more details on how the contest will be operated knowing that risks associated with COVID 19 still exist.

The following considerations are being developed. These are published below to help you decide if this concept of operation is satisfactory for you to attend. Further, if you have other ideas and concerns, please share those with the CD. This is the baseline plan to deviate from.

- We will only have the contest if our size of group is permissible to our host officials at the Salina Airport Authority (SAA) and the requisite regulations form the state of Kansas. The state is currently permitting the counties to set the guidance. The airport in in Saline County. Currently their restrictions & restrictions plan for holding the event trend towards allowing the event to happen. We will monitor and advise any changes.
- 2. Contest COVID 19 requirements will meet or exceed all state and local Kansas requirements.
- 3. We will ask you to wear a mask per the contest and Saline county requirements.
- 4. We will hold all group briefings in the hangar or just outside the hangar. We plan to have an LCD wall and good audio for the hangar to help make this go smoothly.
- 5. We will post orders of flights and results electronically on the large LCD and use the website to avoid congregating around 8 1/2 x 11 pieces of paper taped to walls.
- 6. We will establish clear north and a south starting line on the ramps. This will allow you to get your airplane in position with solid visual cues so we minimize the starter and others finding pilots.
- 7. We will be respectful of the judge's line arrangement with the assistants, recorders, and runners. If judges want to be six feet away from an associate, we will make that happen as we have enough space on the judge's line. There may be some more discerning callouts of scores, but this is a negligible compromise if required.
- 8. We will ask for the judge's line occupants to all have masks and don them per the contest and Saline county requirements such as for a judge conference or when asked to do so by an associate if close together; e.g. Judge, assistant, recorder.
- 9. We will make sure people are comfortable being transported to and from the judge's line in smaller groups versus a crowded van. We will look to secure more pickup trucks for use as required.
- 10. We will provide isolated work spaces on the second floor to allow volunteers to do their job without a crowd. This is possible as the group briefs will be in hangar to eliminate hallway, stairway, and room congestion. We will ask you to be respectful of work spaces.
- 11. We have lots of space and plenty of tables so we can spread out for food events in the hangar more easily then we could crowd into a restaurant or offsite venue. Hence, we will accommodate the contest with onsite dinners on Sunday, Tuesday and Thursday. Monday will be at the Holiday Inn.
- 12. The merchandise area will be on the first floor and we will provide a distancing/barrier at the checkout and ask you to spread out while shopping.
- 13. We encourage you to stay at the Holiday Inn which is the IAC headquarter hotel as these will keep us to the most common group.
- 14. We will provide hand sanitizer and disposable gloves.
- 15. We will identify COVID 19 testing facilities in Salina for use as appropriate.
- 16. We will work with the food purveyors to make sure we follow Kansas guidelines
- 17. Our medical director is Jon Apfelbaum MD and will be on site for the contest.
- 18. Please be advised that if these noted guidelines cause you concern and you do not feel comfortable adopting them, please contact the CD. We will work to accommodate the needs of our membership the best we can within rational limits.
